Acting on behalf of GC Energy Sp. z o.o. with its registered office in Rzeszów (hereinafter referred to as the "Company"), I would like to inform that in the years 2019 - 2022 the law firm M. PLN 800 thousand, from another creditor it enforced the amount of approx. PLN 6 million.
